

PCG: supporting and protecting freelancers, contractors and consultants

Choosing an accountant is an important decision for any freelance consultant or contractor. Whether the need is only for help with drawing up accounts and calculating corporation tax at year-end or for a full-blown accounting and bookkeeping service, the relationship is likely to be a long-term one that needs to be chosen carefully.

PCG is the trade association for freelance consultants and contractors in the UK. We consult our members regularly, and this is what respondents to two of our recent surveys told us:

- Over 88 per cent seek business advice from their accountants (compared to 15 per cent seeking advice from their banks and 9 per cent from business advisers)
- Their choice of current accountant was influenced primarily by recommendations, followed by contractor experience and knowledge of IR35 and S660A, with price being only in third place
- When asked, members most wanted a scheme for identifying accountants who had received additional training on contractor-specific tax and accounting issues and had a good understanding of how freelance businesses operate; 70 per cent rated this as being important to them

PCG's Accredited Accountant scheme was developed in response to this clear and compelling demand.

What is a PCG Accredited Accountant?

The PCG Accredited Accountant scheme is designed to help members choose their accountant by identifying and promoting those who have been given additional and specialist training in freelance-specific issues and have undertaken and passed our exacting training and assessment programme.

- Developed and delivered in association with Accountax Consulting, the PCG Accredited Accountant scheme involves:

Strict entry criteria and rigorous application process

- Two-day training programme on:
 - IR35 (intermediaries legislation)
 - S660A (settlements legislation)
 - Customer service training
- Annual assessment, including feedback from PCG members

How does it work?

The PCG Accredited Accountant scheme (which includes PCG Affiliate membership) is restricted to accounting practices with one or more qualified partners or practitioners and we envisage accrediting no more than one or two practices in a given geographical or postcode area.

To apply for the scheme, the practice needs to complete and submit a detailed application form for review by PCG and Accountax, with a non-refundable deposit. Subject to the application being accepted, the practice can then book places on the next training course.

Although accreditation is for the practice rather than the individual, it is important to have the minimum number of people trained – usually the partner responsible for contractor clients and the person who looks after the day-to-day matters.

- How to argue IR35 in practice
- How to negotiate with HM

What does it cost?

The cost of the scheme is £725 plus VAT for the first partner from any practice and £400 plus VAT for each additional partner or manager from the same office going through the programme.

Affiliate membership is included in this cost.

Except where the firm comprises a sole practitioner, the minimum number of qualified individuals should be two per office – usually the partner responsible for contractor clients and the person who looks after the day-to-day matters.

A non-refundable deposit of £150 per practice is payable on application, and the annual renewal fee is £625 per practice or office, (provided that the individuals who qualified are still with the firm) to include any necessary refresher training for up to 2 participants. Additional delegates will be charged at £180 plus VAT per person.

Benefits to members

The PCG Accredited Accountant scheme complements the other offerings in PCG's range of services and, in response to clear demand from members, the provides the following benefits:
